Re: Eligibility request for change of sporting nationality

The ICF acknowledges the following requests for a change of sporting nationality for the athletes below. All approved athletes in this table are eligible to represent their new country from 1 January 2023. All athletes who have had their request rejected are eligible to continue competing for their former country. Another application can be submitted at the end of 2023 if the required documents are available at this time.

IOC sporting nationality change for the Olympic Games follows stricter rules than ICF sporting nationality change. Any athlete approved or pending below who has competed internationally for their departing country after 25 July 2021 and who wishes to try to qualify for Paris 2024 should contact the ICF for further advice.
