In furtherance to our email of March 27, 2008, I write to inform you that **GHANA ROWING & CANOE ASSOCIATION** has now been formed.


Mr. Gado Ibrahim is the President of the new association with Alhaji Issa and Mr. Saka Acquaye as Vice-President and Secretary respectively.

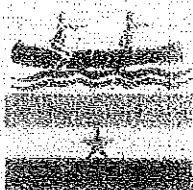
