Re: Eligibility request for change of sporting nationality

The ICF acknowledges the following requests for a change of sporting nationality for the athletes below. All approved athletes in this table are eligible to represent their new country from 1 January 2020. All athletes who have had their request rejected are eligible to continue competing for their former country. Another application can be submitted at the end of 2020 if the required documents are available at this time.

IOC sporting nationality change for Olympic qualification and selection follows stricter rules than ICF sporting nationality change. Any athlete approved or pending below who has competed internationally for their departing country in 2017, 2018 or 2019 and who wishes to try to qualify for Tokyo 2020 should contact the ICF for further advice.
