#### 1. Decision on the Hungarian seat address

The XL ICF Congress approved that the headquarters of the Federation shall be relocated to Hungary. As of now the International Canoe Federation is a legal entity, an association existing under the laws of Switzerland, with its registered office in Lausanne.

From the registration, the Federation shall operate under the jurisdiction of Hungarian law. The headquarters will be situated in Budapest. The exact address is being established by the Board of Directors. The Board of Directors is hereby obligated to pass a resolution specifying the precise address and to provide this resolution to the competent Hungarian authorities for the purpose of

the registration of the relocation of the headquarters.

Decision: In accordance with the decision of the XL ICF Congress, the ICF Board voted in favour to establish the Budapest headquarters at the following address with, one abstention:

#### 2. Declaration on the past and current representation rights

The XL ICF Congress decided to modify the Statutes with effectiveness of the Hungarian registration and explicitly state that the "The ICF President and ICF Secretary General shall be entitled to sign on behalf of ICF and represent the ICF towards third parties. Both of them shall have independent representation right."

This has been the Federation's practice in the past and present.

Decision: The ICF Board voted in favor to declare that according to the past and current practice the following persons are considered to be the legal representatives of the ICF with individual rights of representation, with two abstentions:

- Mr. Thomas Konietzko, ICF President Individual representation right
- o Mr. Richard Pettit, ICF Secretary General Individual representation right



#### 3. ICF proposals for the 2028 Paralympic Programme

The Board reviewed the proposal for the 2028 Paralympic Programme, which includes the request for two additional events: Women VL1 and Men VL1. Additionally, there is a request for 12 quotas per event for existing events, and 10 quotas for the new Women VL1 and Men VL1 events.

Decision: The ICF Board voted in favour to approve the proposal for the 2028 Paralympic Programme, including the addition of Women VL1 and Men VL1 events and the requested quotas, with one abstention.

#### 4. Appointment of a Dragon Boat Committee Advisor

The Board reviewed the nomination of Amnuay Tanphanich (THA) as new Dragon Boat Committee Advisor. His qualifications and background were presented for approval.

Decision: The ICF Board voted in favour to approve the appointment of Amnuay Tanphanich (THA) as a Dragon Boat Committee Advisor, with two votes against.

#### 5. Appointment of a Canoe Slalom Committee Advisor

The Board reviewed the nomination of Rafal Smolen (USA) as a new Canoe Slalom Committee Advisor. His qualifications and background were presented for approval.

Decision: The ICF Board voted in favour to approve the appointment of Rafal Smolen (USA) as a Canoe Slalom Committee Advisor, with one abstention.

### 6. Canoe Slalom ITOs nomination for the 2025 World Championships

The Board reviewed the list of International Technical Officials (ITO) for the 2025 Senior Canoe Slalom World Championships and the 2025 Juniors & U23 Canoe Slalom World Championships. Approval was proposed to this online session in advance of the selection process for continental equivalent competitions to assist with personnel planning.

Decision: The ICF Board voted in favour to approve the list of International Technical Officials for the 2025 Senior Canoe Slalom World Championships and the 2025 Junior & U23 Canoe Slalom World Championships, with two votes against and two abstentions (Appendix 1) and (Appendix 2).



### 7. 2025 Canoe Sprint competition Programme for World Championships and World Cups

The Board reviewed the proposed competition programme for the 2025 Canoe Sprint World Championships and World Cup.

Decision: The ICF Board voted in favour to approve the proposed 2025 Canoe Sprint competition programme for the World Championships and World Cup, with one vote against and one abstention (Appendix 3).
