



COVID SITUATION IN FRANCE

WHAT ARE THE CONDITIONS TO BE CONSIDERED AS VACCINATED IN FRANCE?

The vaccination schedule is considered complete 28 days after the administration of a dose for Janssen vaccine and 7 days after administration of a second dose for other authorized vaccines in France (Pfizer / Comirnaty, Moderna, AstraZeneca / Vaxzevria/Covishield only).

IN WHICH CATEGORY IS MY COUNTRY CLASSIFIED?

The countries have been classified by the French Government as follows:

- "Green list" countries or territories: Countries where no active viral circulation has been reported and no relevant variants identified. These are European area countries (Member States of the European Union as well as Andorra, Iceland, Liechtenstein, Monaco, Norway, San Marino, Switzerland, Ukraine and the Vatican), plus Albania, Australia, Bahrein, Bosnia, Brunei, Canada, Hong-Kong, Israel, Japan, Jordan, Kosovo, Lebanon, Montenegro, New Zealand, North Macedonia, Saudi Arabia, Serbia, Singapore, South Korea, Taiwan, Ukraine, the United States, Union of Comoros and Vanuatu.
- "Amber list" countries: Countries where active viral circulation in controlled proportions has been reported, albeit with no spread of relevant variants. These include all countries not featured on the "green" and "red" lists.
- "Red list" countries: Countries where active viral circulation has been reported, including relevant variants. These include the following countries: Afghanistan, Argentina, Bangladesh, Brazil, Costa-Rica, Cuba, Democratic Republic of Congo, Indonesia, Maldives, Mozambique, Namibia, Nepal, Oman, Pakistan, Russia, Seychelles, South Africa, Sri Lanka, Suriname and Tunisia.

Please note that if you are present for more than 14 days consecutive days in one of the European area countries, you are considered as coming from it. You must be able to prove it (invoices, airplane tickets etc...)

IS THE 2021 ICF CANOE SLALOM WORLD CUP FINAL A COMPELLING REASON TO ENTER FRENCH TERRITORY ?

The French Sports' Ministry considers this event as a compelling reason to come to France for green countries.

An invitation letter is necessary for :

- Not vaccinated people coming from amber countries
- Vaccinated and not vaccinated people coming from red countries.

HEALTH CONTROL MEASURES

<u>I am coming from a "Green country" :</u>

- If you are already vaccinated, you must present proof of vaccination status and a <u>sworn</u> <u>statement</u> attesting to the absence of symptoms of covid-19 infection and contact with a confirmed case of covid-19.
- If you are not vaccinated, you must present to the transport company and border control authorities a certificate of recovery older than eleven days and less than six months or a negative PCR or antigen test not older than 72 hours before departure (departure of first flight in the event of a connecting flights). Some countries in the European area have been placed under surveillance. For unvaccinated travelers from Cyprus, Spain, Greece, Malta, the Netherlands and Portugal, a negative PCR or antigen test of less than 24 hours is required.

Children under the age of twelve are exempt from testing. You must also present a sworn statement attesting to the absence of symptoms of covid-19 infection and contact with a confirmed case of covid-19.

<u>I am coming for a "Amber country" :</u>

- If you are vaccinated, you must simply present proof of your vaccination status and a sworn statement certifying the absence of COVID-19 symptoms and of any contact with a confirmed case of COVID-19.
- If you are not vaccinated, you must present the transport company and border control authorities with a negative PCR test taken less than 72 hours prior to departure or a negative antigen test taken less than 48 hours prior to departure. If you are from the United Kingdom and are not vaccinated, you must present a negative PCR or antigenic test taken less than 24 hours prior to departure. The departure of the first flight in case of connecting flights. Children aged below twelve years are exempt from testing.

You will also need to present :

- A sworn statement certifying the absence of COVID-19 symptoms and of any contact with a confirmed case of COVID-19;
- A sworn undertaking to take an antigen test or biological examination on arrival in metropolitan France;
- A sworn undertaking to **self-isolate for seven days**, and another sworn undertaking to take a biological virological screening test (PCR) at the end of the isolation period.





<u>I am coming from a "Red country" :</u>

- If you are vaccinated, you must simply present proof of you vaccination status (28 days after the administration of a dose for Janssen vaccine and 7 days after administration of a second dose for other authorized vaccines in France (Pfizer / Comirnaty, Moderna, AstraZeneca / Vaxzevria/Covishield only) and a sworn statement certifying the absence of COVID-19 symptoms and of any contact with a confirmed case of COVID-19.
- If you are not vaccinated, you must present the transport company and border control authorities with a negative PCR or antigenic test taken less than 48 hours prior to departure (departure of first flight in case of connecting flights). Children aged below twelve years are exempt from testing. If you are not vaccinated, you will systematically be subject to a quarantine or isolation measure which will be announced in a prefectoral order on your arrival in Metropolitan France for a ten-day period, which will be accompanied by a restriction on the hours for leaving the place of isolation (except in the case of transit in an international zone). You will also need to present:
 - A sworn statement certifying the absence of COVID-19 symptoms and of any contact with a confirmed case of COVID-19;
 - A sworn undertaking to take an antigen test or biological examination on arrival in metropolitan France;
 - Proof of home address or proper accommodation (hotel or equivalent), specifying, where applicable, how control officers can gain access to confirm compliance with the quarantine or isolation measures, except in cases of isolation in an accommodation facility provided by the administration (territorial isolation support units have been set up to assist isolated persons) or of transit in an international zone.

The situation is evolving quickly, as are the rules. The ICF and the FFCK will keep you informed of the major changes, but you can get the current regulation on the French Government website : https://www.interieur.gouv.fr/Actualites/L-actu-du-Ministere/Certificate-of-international-travel

IS THE EU DIGITAL COVID CERTIFICATE ENOUGH TO ENTER PAU WW STADIUM?

The information above concerns only the entry on the French Territory and the access to the city of Pau. The ICF COVID Protocol shall be applied since the beginning of the competition.

I AM VACCINATED BUT FROM A FOREIGN UE COUNTRY, HOW CAN I GET A DIGITAL COVID CERITIFICATE?

In order to get your EU DIGITAL COVID CERTIFICATE, your vaccination schedule must be complete, and you must have been vaccinated with one of the vaccines recognized by the French Authorities (Pfizer / Comirnaty, Moderna, AstraZeneca / Vaxzevria/Covishield / Janssen).
