#### **B.** Bibs distribution

- CSL Competition bibs will be available from the terrace from 10.00 on the Thursday 25.08.2022. All training bibs have to be given back at the same time.
- The accreditation fee must be fully paid to receive competition bibs.
- A bib deposit of 100 Euro per team is required on collection of the bibs.
- CSL Competition bibs must be returned to the Sport Information Office following the competition for the return of the deposit.

# C. Technical Video Service for CSL events

- A TVS feed will be available for all events and both demonstration runs.
- Only the download solution will be available. Each Nation tent will be equipped with their own download cable.
- Please enable the option "Automatic (DHCP)" Hans- Peter WEISS can assist
- Address to use to download videos: <u>http://cis.siwi</u>
- The first access to http://cis.siwi may take a bit longer, sometimes 1-2min.
- WLAN must be "not activated" (off) not only "not connected" to a WLAN-network
- All devices must be connected at the testing time, 14:00 Thursday, so we know the system works under the full load.
- Wireless routers may be used only if they are **NOT** within the following frequency

5785 GHz, band width +/- 20 MHz

5825 GHz, band width +/- 20 MHz.

- Any wireless device in these frequencies may affect the delivery of the competition.
- At no time should any wireless router system be connected to the computer which is connected to the TVS lan cable.
- All devices, including any wireless routers, must be named with National Federation code and device number eg AUS1, AUS2, AUS3 – unnamed devices will be removed from the system.
- Any team found to be using a device affecting the competition will have power removed to their complete system.

#### **D. Pre-start procedure**

• There will be a clock, on the left bank, facing upstream into the warm-up area showing race time and the next athletes to start.

#### E. Start



- Athletes may move to the start position once the previous Athlete has broken the beam but must be at the start position 15 seconds before their start.
- The starting boat must be alongside the pontoon in front of the partners' panel.
- At the start, there will be a countdown clock showing the time to start. There will be an acoustic signal (10 seconds before start, and then from 5
- Athletes may start 5 seconds either side of their official start time which is signified by the long beep on the start clock.



• The beam line is under the bridge, on the dropping line.

seconds before start - 4 shorts, 1 long - start).

• At all times, the athletes must follow the Starter's instruction, or they may be disqualified for the run.







#### F. Finish



- The beam line will be indicated by two flags "FFCK" and 2 boards "finish".
- Athletes must exit via the pontoon (right side of the finish pool) to pass through equipment control, "Kiss and Cry" area and the mixed zone (which is at the top of the stairs).
- During the finals, the leading and second athlete must proceed to the "Kiss and Cry" area located after equipment control where TV will interview them. If the second Athlete is not comfortable to remain in the Kiss Cry (covid reasons) they may leave.
- Athletes must not leave the finish zone until dismissed by the Equipment Control Official once they are no longer needed for the ceremonies, anti-doping or equipment control.
- They then proceed via the mixed zone back to the Athlete area.
- Athletes should wear their competition bib in the mixed zone for identification purposes.





## **16.** Extreme Kayak events – race information

#### A. Course design timetable

- Extreme Kayak course map will be distributed at the Sport Information Office, and on the WhatsApp Group on Friday 26.08.22 at 15.00.
- The course design will remain the same between Time Trial, Heats and Final elimination phase. Upstream gates left and right for time trials will be defined on the course design. For the final elimination phase (from the quarter-final heats to the final), downstream gates may slightly move before the start of the quarter-final heats to increase the difficulty of the course.

## **B. Bibs distribution**

- For time trials, Athletes' bibs will be distributed from Sport Information Office with the CSL bibs. These need to be returned following the time trials, to the Sport Information Office after the athlete has finished the TT.
- For the elimination phases the Athlete bibs will be distributed from Sport Information Office and will be available on Saturday 27.08.22 after the Time Trials.
- All Extreme Kayak bibs must be returned to the Sport Information Office, following the competition.
- A deposit of 100 euros (the same 100 euros as paid CSL so one payment) will be required which will be returned when all bibs are returned.
- For Time Trials:



For elimination phases, numbered bibs (1 to 32) will be given at the Sport Information office straight after the official results of the time trials.









 In each bracket Athletes will also place over their number bib a colour bib to designate their ranking in the time trial. These bibs will change around depending on who proceeds and will be distributed directly before each bracket by the pre Start Official. Athletes must return the coloured bibs to the dedicated HOC volunteer at the finish take out after their run.

Highest ranked = **Red**, 2<sup>nd</sup> ranked = **Green**, 3<sup>rd</sup> ranked = **Blue** and 4<sup>th</sup> ranked = Yellow

## C. Start & Finish line

- There will be an automatic start machine.
- The start will be by given using the lever on the back of the platform.
- The timing will be done by photocells.
- The finish line for Time Trials and the Elimination phase will be located as showen on the picture.









#### **D.** Time trials

- Access to the start ramp will be from the right bank.
- Time trials will use the automatic start machine.
- Athletes must start from <u>lane 3</u> on the platform for the Time Trials.
- Time trials will be run with gates.
- Timing will be done:
  - o At the start: by photocells.
  - o At the finish: with photocells.
- The signal to start will be "Ready" after a random period the starter will give the start by pulling the lever.
- No "Go".





#### E. Elimination phases

#### Pre-start procedure

- Athletes need to be at the start area prior to their heats to prepare their boats and receive the final instructions.
- Athletes may warm up in their own CSLX boat or a boat provided by the organiser.
- Access to start ramp will be on the right bank.

#### Start Procedure

- The automatic start machine will be used for the elimination phases.
- Athletes should be settled in the start position on the ramp 90 seconds before their start time. There will be volunteers to assist them if needed.
- They should then listen to the sports presentation where they will be introduced to spectators (start from lane 1 right bank to lane 4 left bank).
- At all times they should follow the starters instructions.
- The start position is with both hands on the paddle and the paddle in horizontal position along the side of the kayak.



#### Finish

• Finish line will be indicated on the course map.







- Please return the borrowed boats, spraydecks and bibs to the start via the conveyor belt.
- Volunteers will be there to help you to bring the boat to the ramp, put the spraydecks.
- There will be a person at the start to inform you if you have progressed.
- After the final phases, Athletes must exit through the "Kiss and Cry" area and the mixed zone. Please remind them that they have to be on time for medal ceremonies.

#### Rules reminder

- Minimum weight 18kg. Pre-competition control during Time Trials and Elimination phase.

- All buoyancy must above the waist, meet EN norms see:
  <u>https://www.canoeicf.com/sites/default/files/2022\_extreme\_kayak\_buoyancy\_rules\_v1.pdf</u>
- No sharp edges on the paddle, CSL paddle should be taped even for time trial.
- Athletes may NO longer use their CSL helmets and paddles with sharp edge must be tapped also for Time Trials. Listed Extreme kayak helmets are required for both Time Trial and Elimination phases.
- In Time trial and Elimination Athletes must wear long sleeves.
- In Elimination phase the two Athletes who come first in the previous bracket choose their places first (according to their time trial rank) followed by the two Athletes who came second (according to their time trial rank).
- If an athlete or their equipment falls from the platform before the "Ready" = DNS.
  They must exit from the start platform or the course.
- No movement between "Ready" and the tilt of the Start machine, otherwise False start = FLT.
- False start = a Fault (FLT).







- Whole head and both of the shoulders must cross the gate line in the correct direction.
- Not permitted to move the gates in an unfair way to disadvantage others = RAL.
- Are permitted to "reach across" but not hold back.
- An Athlete with a broken paddle must drop back and/or paddle down the course alone. If they do not, the broken end of the paddle is considered dangerous = RAL.

They may drop the broken paddle and use their hands to finish the course.

- No dangerous contact with head or body of other Athletes.
- FLT for wrong negotiation, ranked as lower (RAL) for not following safety rules.
- Using a photo finish to break tie in the elimination phase bow line first across the line.







#### For Vote at this meeting

#### Roll Zone/Barrier

Existing rules:

16.19.5 - The course must contain a marked roll zone or a roll barrier.

16.22.5-For the roll zone, the boat must make a complete 360-degree roll within the marked area.

16.22.6 - For the roll barrier, the boat must make a complete 360-degree roll with the boat starting to roll before the barrier.

For this in both Time trials and Elimination phases we combine these two rules

The proposal is:

16.19.5 - The course must contain a marked roll zone **and** a roll barrier.

#### Hands on Paddle

Existing rule:

16.22.3 - Athletes are permitted to touch the gates with any part of their body or equipment.

For this competition in both Time trials and Elimination phases the proposal is:

16.22.3.a - Athletes are permitted to touch the gates with their hands only if both hands are on their paddle.

#### **17.** Key areas during competition

#### A. Enquiry / Protest desk

• The Enquiry desk is located in front of the OVR.

#### **B. Equipment control**

- Equipment Control is located next to the exit on the right side of the finish pool (see map in annex).
- Self-checking is open:
  Wednesday 24.08.2022 from 11.00 to 19.30.

Thursday 25.08.2022 from 8.00 to 15.30.





- Equipment control will be open each day 1h before the 1<sup>st</sup> boat starts.
- There will be post competition control and random checking during whole CSL Competition. Equipment control for CSLX shall be as set out in section 16 above.

#### C. Medal ceremonies

- Location: see map in Appendix 1.
- Schedule: see competition schedule, after each session of final.
- Athletes involved in the Finals for both Canoe Slalom and Extreme Kayak should bring their national uniform to the medal ceremony preparation area. There will be boxes there to place the uniform in. There is only a short time between the end of the competition and the medal ceremonies.
- Athletes and team leaders are asked to respect strictly the COVID 19 protocol during the ceremonies (no handshakes, no kisses, no grouping together for pictures).

#### **D. Doping control station**

- The doping control station is located in the first aid room on the ground floor of the main building (beside the elevator).
- Athletes will be notified for Doping Control in the finish area.
- Passports or ID are required for Athletes selected for doping control.

#### **E.** Special information for the National Federation

- Additional tents are allowed in the athlete village area, only if they are well attached to the ground (to prevent thunderstorm damages).
- Car parking for Teams is located on the right side of the entry road, the parking pass is required.







# **18.** Athlete's video and photo for TV graphics and sport presentation

The ICF will shoot a video (8s without sound) of athletes for sport presentation. Athletes, who have not yet had a video taken, (they have been advised of this directly) should attend this short shooting session (maximum 2 minutes) in national uniform. Any other Athletes are welcome to update their video if they wish, when the studio is open and not too busy. The Green Box studio will be in the Press room (Workforce room on the ground floor of the main building) and is open on Thursday 25.08.22 from 11:00 – 17:00.
