All athletes, coaches, and support personnel must have completed the relevant anti-doping online course on the WADA Anti-Doping Education Learning platform (ADEL) corresponding to their role. The certificates showing completion should be sent by each National Federation to <u>manuela.gawehn@canoeicf.com</u>. Previous certificates are still valid for this season. There is no need to repeat the program unless the person's role changes (e.g. athlete becoming coach).

Accreditations will not be issued until the certificates are marked off.

Rule 1.6.1.f - In extraordinary circumstances, an application can be made to the Technical Chair for the acceptance of late nominal entries from National Federations. It is the Technical Chair's discretion to accept or decline a late entry. Late entries to the competition will incur a fee of 50 euros per athlete in addition to the participation fee.



12. Closing of the course

The course is closed 15 min before the first official start each day until 10 minutes after the last athletes pass the finish line on the whole course.

13. Pre-Start Control

The pre-start control will be on the pontoon near the boat entrance. All athletes have to pass the pre start control. There will be a signage on the bridge to call the athletes to go down to the eddy before the releasing point.



14. Start and Finish location and procedure

A. Start procedure – individual events

- Boat will be held on the left bank and released from 0 after the countdown has finished
- Athletes are responsible to get themselves to the start position on time.
- There will be a clock facing upstream into the warm-up area showing race time and the next athletes to start.
- One boat at the start and the following competitor could stay behind the releasing point.
- The beam line is behind the bridge and will be indicated by two poles.
- At the start, there will be a countdown clock (bank) showing the time to start. There will be an acoustic signal (15 seconds before start 4 shorts, 1 long start).
- Athletes must start **within 3 seconds of** their start time.
- At all times, the athletes must follow the Starter's instruction, or they may be disqualified for the run.
- The course is closed 15 minutes before the first competitor each day.

B. Start procedure – team events

- All boats will be held, 1 boat from individual start position and 2 boats upstream on right bank.
- It doesn't matter which of the three boats cross the start line at first. All boats must pass the start within **15 seconds from the "0".**









C. Finish

- The beam line is in front of the finish tower.
- Athletes must exit on the river left and pass through equipment control and for Final the mixed zone on the top of the finish tower.
- Athletes must not leave the finish zone until dismissed by the equipment control judge once they are no longer needed for the ceremonies, anti-doping or equipment control.
- As soon the athletes leave the boats at the finish they maybe be required for a quick comment regarding their run then for finals the leading athlete must proceed to the Mixed Zone area.
- During this process, each athlete must wear his competition bibs.

15. Course approval

The course must be approved by a simple majority of the present.

16. Start Interval

- Sprint Heats 45 seconds
- Sprint Finals and Teams 90 seconds

17. Results

- HOC will compile the results using "Siwidata".
- Results will be posted on the official notice at the enquiry desk
- Live results will be available on a viewer at the enquiry desk.

- Official or Unofficial mark will be given on the live results link for each category
- Live streaming on the Planet Canoe channel of the Recast plaform

18. Location of Inquiry / Protest desk, Protest fee

- The Inquiry desk is located behind the big screen, left bank, close to the finish line.
- Access to this area is limited to accredited Team Leaders only.
- The Protest fee is 75 euros

19. Equipment measuring and post competition control

- Equipment Control is located at the end of the course and is open for self-checking: Thursday June 08 and Friday June 09 from 9:00 to 15.00
- Equipment control station can be used also each day of competition 15 minutes before each Wildwater canoeing official competition start times.
- There will be random post equipment control conducted throughout the Heats, all qualified athletes go through equipment control for Finals.
- Safety advice: airbags must be full pump. All other aspects following the rules.

20. Doping control

The doping control station is located in the BLZ (left bank of the Eiskanal)

- Athletes will be notified for Doping Control at the finish area.
- ID card or passport will be requested.



21. Awards Ceremony, Time and Location, Dress requirement

- Location: Olympic channel
- Schedule:
 - Opening Ceremony: Friday 9th June Meeting 16:00 in front of race office, Nation
 Parade for whole team please prepare one athlete to carry the flag
 - Sprint individual and team medal ceremony, Nation Cup : Sunday 11th June 15:30
- For events that are not valid, there will be only flower ceremonies (without medals and anthems).
- For Opening and medal ceremonies, athletes, medallists, team staff and leaders of the must attend the meeting wearing proper National Federation Uniforms.
 For medal ceremonies, the Team leaders of the gold medallists must attend the ceremony.

22. Water Safety and rescue

- The water rescue service will be located along the course as required.
- Please follow their instructions at all times.
- A medical service team can be found near the "Bogenbrücke" (the middle bridge)

23. National Federations parking

- From Friday 09th of June 12:00, car parking for Teams will be at the soccer grounds as you enter the venue (P3 on the Venue layout).
- Parking passes are required and are available from the HOC at the Race Office.
- It is not allowed to ride neither to walk with a bike in the public areas during competitions.



24. ICF subjects


