# 1. Introduction

This ICF Board of Directors meeting was held following the ICF Congress in Rome. Participants took part either in person or online due to the world pandemic "Coronavirus COVID-19".

The meeting was chaired by **Thomas Konietzko**, who was elected President of the ICF by Congress 24 hours earlier.

Mr Konietzko thanked outgoing President **Jose Perurena** for his outstanding leadership over 13 years. He emphasised the importance of working as a team and of everyone's opinions being important.

He said now was the right time to review everything, and to start a general discussion about the future direction of the ICF. He expressed his confidence in the ICF Staff and thanked them for the great work in the Congress preparations.

## APPOINTMENT ICF WHITEWATER TECHNICAL MANAGER

The ICF slalom committee chair announced Christoph Kirsten would be offered the role as ICF whitewater technical manager, replacing Cyril Nivel who has joined Paris 2024. Mr Kirsten had a wide range of experience in whitewater and would be a great appointment. He would be contacted to negotiate contract and conditions.

#### **OPENING DISCUSSIONS**

ICF vice-president, Cecilia Farias, said she would like to see more coverage of the election of women to senior ICF positions. Mr Konietzko said it was one of his main priorities to increase the number of women at top levels of the Federation.

Canoe polo committee chair said he would like to see more positive comments about the work that is carried out by the ICF office. He said the comparisons provided by Mr Perurena of the office sizes of different International Federations showed the ICF is functioning very well.
